



1 YEARS PARTS AND LABOR LIMITED WARRANTY

Limited Warranty

American Top Lift warrants to the original purchaser that its product shall be free from defects in materials or workmanship under normal operating conditions for a period of 1 years. This limited warranty is subject to the conditions listed below, and is limited to defects in workmanship and material by American Top Lift or Nation Tank and Trailer.

Responsibility of American Top Lift under this warranty is limited to the replacement or repair of the parts determined to be defective. Warranty coverage is subject to review and inspection of defective material. Coverage shall include approved parts and flat rate labor as approved by American Top Lift or an approved American Top Lift Dealer.

Damage Limitations

The above warranty does not include damages caused by improper operation, overriding safety features, overloading, usage other than loading and unloading and alteration of parts. American Top Lift is not responsible for any damages and liability due to the failure caused by incorrect operation of the product.

Neither American Top Lift nor any authorized service center shall be responsible for any incidental or consequential damages, loss of use of the crane, loss of time, profits or income, inconvenience, commercial or economic loss, or any other consequential or incidental damages.

American Top Lift will not be liable for any damage, operation failure, property or personal injury caused by improper installation of the products by the installer.

Purchaser's Obligations to Receive Warranty Coverage

Purchaser must submit the Limited Warranty Registration Card or submit online, within 30 days of delivery to activate warranty coverage. All warranty repairs must be performed by an approved American Top Lift Dealer or authorized service center. Warranty approval or denial is at the discretion of American Top Lift. This Limited Warranty does not cover transportation or freight to or from an authorized service center for repairs. All transportation and freight charges are the responsibility of the purchaser.

American Top Lift is not under any obligation to provide warranty to a customer who does not sign the warranty card and send it back to American Top Lift via email or mail within 30 days of receiving the product.
